No. 6 and the fee for the second instance decision in the amount of RSD 550.00 under Tar. No. 9 of the Law on Republic Administrative Fees ("Official Gazette of RS", No. 43/03, 61/05, ..., 95/18 and 38/2019).

Note: the person authorized to represent the association has an obligation to register the beneficial owner in the Central Register of beneficial owners within 15 days from the day of registration of the establishment, under the threat of liability for administrative offences.
